Roth Deferrals *grow*

tax free and can be

distributed tax free in

your retirement stage

"Diversify your taxes"

"Tax Free Growth"

"Tax Favorability passes forward at death"

Consider:

Taxes today vs taxes in the future – which will be higher?

Note: tax rate is 12% or less on gross income under \$117,500.
